How to Enroll

Families will enroll online through the TADS system. Enrollment fee is paid through TADS at time of enrollment. Enrollment will not be considered final until the fee is paid.

- Current Families - Use your current TADS tuition account to enroll for the upcoming school year.
- New Families - Contact the school office for more information on establishing an online TADS account to begin the enrollment process. This enrollment link will open for 2021-2022 on the dates listed below.

Enrollment Fee

Current St. John the Baptist Students:

- K-4 Students (2021-2022) \$100 non refundable registration fee per student (maximum of \$200 per family). If registered by January 15, 2021, this fee will be applied towards 2021-2022 student tuition account
- Pre-Kindergarten (2021-2022) Students- \$50 non refundable registration fee per student. If registered by January 15, 2021, this fee will be applied towards 2021-2022 student tuition account.

New Students to St. John the Baptist Catholic School:

- K-4 Students- \$100 non refundable registration fee per student (maximum of \$200 per family). Fee will be applied towards student tuition account if the student is successfully enrolled by December 1, 2021.
- Pre-Kindergarten Students- \$50 non refundable registration fee per student. Fee will be applied towards student tuition account if the student is successfully enrolled on December 1, 2021.

Special Kindergarten Bonus

All 2021-2022 Kindergarten students (new and returning) who register by January 31, 2021 will receive a bonus \$150 toward their tuition account. This is in addition to the \$100 registration fee being applied toward tuition if they are registered by February 28 2021. This generous offer is made possible by CSCOE.

**If a student enrolls and then withdraws prior to the first day of the 2021-2022 school year, the non refundable registration fee will not be returned to the family.

Tuition for 2021-2022 School Year

K-4 Program Tuition

- 1st Child - \$3,000
- 2nd Child - \$2,900
- 3rd Child - \$2,700
- 4th Child - \$2,000

Pre-Kindergarten Program (3, 4 and 5 year old)

- 5 All Days - \$500/mo (Mondays-Fridays)
- 3 All Days - \$300/mo (Mondays, Wednesdays, and Fridays)
- 2 All Days - \$200/mo (Tuesdays and Thursdays)

- 5 Half Days - \$300/mo (Mondays-Fridays)
- 3 Half Days - \$180/mo (Mondays, Wednesdays, and Fridays)
- 2 Half Days - \$135/mo (Tuesdays and Thursdays)

Student Fees

Textbook/Technology Fee

- \$50 per K-4 student

Activity Fee

- K-4 Students - \$70 per student
 - Includes 3 all-school field trips (\$15 each), 3 class holiday parties (\$5 each), and class silent auction donations for Parish Festival and Bingo Fun Day (\$5 each).
 - Other grade specific field trips will be an additional fee.
- Pre-Kindergarten - \$25 per student
 - Includes 3 class holiday parties (\$5 each) and class silent auction donations for Parish Festival and Bingo Fun Day (\$5 each)
 - Field trips will be an additional fee.

Enrollment Timeline

- **November 1, 2020:** Financial Aid application opens for K-4 through TADS and Pre-K through Schulze Early Learning Scholarship. See the Financial Aid section below for further details.
- **December 3, 2020:** Online enrollment/registration begins through the TADS system for current students.
- **January 15, 2021:** Enrollment due for current PreKindergarten through 4th grade families in order for \$100 and \$50 per student registration fee to be applied toward 2021-2022 tuition and to hold your spot.
- **January 18, 2021:** Online enrollment/registration begins through the TADS system for new students
- **January 28, 2021:** New families accepted based on enrollment priority list. Applications received after this date will be accepted on a first come first served basis.
- **January 31, 2021:** Online enrollment/registration DUE through the TADS system for Kindergarten students seeking CSCOE special \$150 bonus.
- **February 15, 2021:** Applications due in the TADS system for K-4 financial assistance.
- **March 19, 2021:** TADS financial assistance awards through Aim Higher and Catholic Service Appeal will be announced to families.

Financial Assistance

We are blessed with generous foundations and private donors to support the education of our students. We have two financial assistance opportunities for families, based on the age of the student.

K-4 Student Financial Assistance

All families wishing to apply for financial assistance for their K-4 student(s) must complete an online application through the TADS system. This is a third-party organization who collects the required financial data from each family. Your individual financial documents will not be shared outside of this organization. TADS will provide the principal and pastor with a “recommended” family level of commitment to tuition. The principal and pastor will use this information to determine scholarship assignments from private donors.

Through the TADS system, each family may also apply for the Aim Higher and Catholic Service Appeal scholarships. **You must check the boxes for these two scholarships in the TADS system to be eligible.** These organizations will use the financial determination from the TADS system to make their scholarship awards. The application for these two awards is due **FEBRUARY 15, 2021**.

- **To apply:** If you currently have a TADS account, simply apply through that account. If you do not have a TADS account, contact the school office to establish an account.
- **Awards:** For applications received by February 15, 2021, the families will be notified by Aim Higher and Catholic Service Appeal by March 19, 2021 for award of either of these scholarships. For private scholarships families will be notified by the principal when a determination has been made.

Pre-Kindergarten Financial Assistance

The Schulze Family Foundation is once again offering the Schulze Early Learning Grant to Pre-Kindergarten students who are in their final year before kindergarten. This scholarship is meant for middle-income families, to help support a pre-kindergarten student in catholic education. There is no deadline for this scholarship, as scholarships are awarded on a rolling basis. The earlier you apply, the better chance you have of receiving assistance for the 2021-2022 school year.
